

Fitness First #ThatMoment Contest Terms and Conditions

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

1. **Eligibility:** This Campaign is open only to those who are current Fitness First members and who are 18 years of age or older as of the date of entry. The Campaign is only open to legal residents of Singapore and is void where prohibited by law.
